NOTIFICATION

Navodaya Vidyalaya Samiti, an autonomous organization under the Ministry of Education (Department of School Education & Literacy) vide its notifications dated 14.02.2023 which was published in its website of Samiti and Employment News dated 04-10 March-2023, invited applications through proper channel for filling up 01 (one) post of Executive Engineer in Level – 11 of the pay matrix of 7th CPC on **deputation basis** for its Hqrs. at NOIDA.
